Terms and conditions:-

1. Cost of the work: The total cost of works shall not exceed Rs.15,66,814/-(Rupees Fifteen Lac Sixty Six Thousands Eight Hundred Fourteen Only) and no excesses whatsoever shall be allowed to cause except to the extent as provided in NIT / agreement clause if any. The individual rates of the items shall not construe to be the bench mark for cost determination of that item.
2. Date of start and date of completion. The date of start of the work shall be reckoned within one week from the date of issuance of this allotment and completion period / expiry of the contract shall be 25 calendar days.
3. Visual proof/Photography of work. The visual proof of each item or part of its work executed by way of pre / during post Geo-Tagged photographs duly signed by engineer in charge shall be appended with each claim at the time of submission of the bill.
4. Earnest Money: - The call deposit receipt worth Rs. 30720 bearing No 32174 dated: 17-5-22 from J & K Bank, B/U Ichgam and pledged to Executive Engineer, PHE, Jal Shakti Budgam has been retained by this office.
5.
